MOOT COURT COMMITTEE

Moot Court is a simulation of a court hearing, in which participants analyse a problem, research the relevant law, prepare written submissions and also present an oral argument. The moot problems are typically set in areas of law that are unsettled or that have been subject to recent developments. It is an imitation of the entire court proceedings which has to be done by the students for better understanding of the subject.

A Moot Court is a mock court at which law students argue on imaginary cases for practice. On 16th September 2020, School of Legal Studies at K. R. LEGAL AID COMMITTEE

School of Legal Studies, K.R. Mangalam University, Gurugram in order to give students practical exposure and to honour the guidelines of Bar Council of India has set up a Community Legal Aid Clinic and a Legal Aid Committee in the University. The activities of the Legal Aid Committee include among other dissemination of legal literacy and assist in pro-bono legal aid and knowledge to the society and conduct legal awareness camps; visits to prison, courts, juvenile homes; and organising conferences and seminars. These field activities would develop analytical skills amongst the students to practically understand the legal issues people are facing. It will also compel them to apply correct application of laws and suggest remedies available thereof. This would cater to the broader legal aid framework of the nation and will uphold constitutional values.

CLIENT COUNSELLING COMMITTEE

The Client Counseling Committee forms an integral part of School of Legal Studies (SOLS) at K. R. Mangalam University, Gurugram. One of the primary functions of a lawyer is counseling the client. Legal profession like medical profession is a “helping profession.” Traditionally legal counseling was viewed as the lawyer advising the client regarding the client’s legal problem. In counseling usually the lawyer exercises a great deal of control over the outcome of counseling. In this whole exercise, the client becomes a passive spectator if not a mute spectator. This often results in the lawyer taking decisions on behalf of the client. This in fact had become an acceptable professional practice.

The fundamental aim of this committee is to focus on the functions of a lawyer in a holistic manner, especially by providing a unique opportunity to have a deep insight into the behavioral aspects of counseling while dealing with the clients. The Client Counselling Committee was started because we believe that dealing with the clients is an integral skill that a lawyer should possess. Client counselling requires that lawyer assist the client in the way he/she needs rather than the lawyer taking any decisions on behalf of the client. Counseling is all about giving such information which a client would like to know regarding his legal problem/case. In order to satiate the client, a lawyer is expected to have excellent listening and advisory skills.
