Guidelines for Faculty Members and Research Scholars from the HEIs (Universities/Colleges) across the country to participate in 6 Days' Basic Training Programme in Bharatiya Jnana Parampara (IKS)

Applications are invited from the Faculty Members and registered Research Scholars from HEIs (Universities/Colleges) across the country to participate in the '6 Days' Basic Training Programme in *Bharatiya Jnana Parampara* (IKS)', going to be organized by UGC.

Aim:

The National Education Policy (NEP) of 2020 underscores the pivotal role of *Bharatiya Jnana Parampara* (IKS) within the fabric of Indian education. It champions the core principle of embracing our roots, fostering pride in India, and celebrating our rich, diverse cultural heritage—both ancient and modern. The NEP envisions an educational ecosystem deeply rooted in Indian ethos.

To actualize this vision, the NEP advocates for curricula and pedagogy firmly grounded in the Indian context. It seeks to infuse the corpus of Indian Knowledge System across disciplines in higher education institutions (HEIs) nationwide. As part of this endeavour, a comprehensive training program aims to equip faculty members with the tools and insights necessary to integrate IKS seamlessly into their teaching practices.

Target Group:

Across a grand total of 75 institutions, the training program is set to run from November 2024 to March 2025 to equip 10,000 faculty members and 1,000 registered research scholars from universities and colleges across the nation.

Selection Criteria:

Faculty Members working in Higher Education Institutions (universities and colleges) and Research Scholars who are pursuing Ph.D. in regular mode are eligible to apply.

The decision of UGC is final in selection of Faculty Members and Research Scholars and in allotting/allocating a particular HEI to attend the Training Programme. No request for change in the HEI will be entertained in any case.

However, the rights to relieve the faculty or the research scholar rests with the Competent Authority of the HEI. So, it is better for prior intimation and to get proper permission to attend the training programme.

Financial support:

Faculty Members and Research Scholars are allowed to get accommodation (lodging/boarding) and reimbursement of TA (Travelling Allowance) from the host institution. The details of mode of travel for reimbursement and other details will be communicated at the time of attending the training.

Procedure to apply:

Faculty Members/Research Scholars may submit the Google Form from their personal email address. On selection to attend the Training Programme, No Objection Certificate / Relieving letter from the Employer i.e. Competent Authority of the concerned HEI.

Last Date for submission: 15th OCTOBER 2024
