## **Guidelines for interested HEIs (Universities/Colleges) for submitting applications to conduct Basic Training Programme in Bharatiya Jnana Parampara (IKS)**

Applications are invited from the HEIs (Universities/Colleges) which are interested to conduct 6 Days' Basic Training Programme in *Bharatiya Jnana Parampara* (IKS).

### **Aim:**

The National Education Policy (NEP) of 2020 underscores the pivotal role of *Bharatiya Jnana Parampara* (IKS) within the fabric of Indian education. It champions the core principle of embracing our roots, fostering pride in India, and celebrating our rich, diverse cultural heritage—both ancient and modern. The NEP envisions an educational ecosystem deeply rooted in Indian ethos.

To actualize this vision, the NEP advocates for curricula and pedagogy firmly grounded in the Indian context. It seeks to infuse the corpus of Indian Knowledge System across disciplines in higher education institutions (HEIs) nationwide. As part of this endeavour, a comprehensive training program aims to equip faculty members with the tools and insights necessary to integrate IKS seamlessly into their teaching practices.

### **Target Group:**

Across a grand total of 75 institutions, the training program is set to run from October 2024 to March 2025 to equip 10,000 faculty members and 1,000 research scholars from universities and colleges across the nation.

### **Selection Criteria:**

Universities and colleges with robust infrastructure facilities, capable of accommodating 150 participants and 10 experts for lodging and boarding, along with an auditorium or lecture hall, and a track record of conducting at least one national or international level workshop or training program, are eligible to apply.

The decision of UGC is final in selecting the HEIs and further preparing calendar for the programme. Also, the list of Guests/Experts/Participants will be finalized, only by the UGC.

### **Budgetary provisions:**

Selected HEIs (Universities/Colleges) will be granted with a budget of sum of Thirty-Three lakh rupees (Rs.33 Lakhs only). Fifty percent (50%) of grant will be released in advance before conducting the training programme and the remaining amount after submitting the statement of expenditure along with utilization certificate.

This budget includes TA/DA to Guests/Experts and only TA for Participants (Faculty Members/Research Scholars) and for inhouse accommodation (including lodging and boarding); Training KIT and remuneration to the Guests/Experts and for any other miscellaneous expenses or contingency.

### **Procedure to apply:**

HEIs must submit the Google Form from the official email address of the Competent Authority.
