Greetings from Haryana State Higher Education Council

Haryana Govt. has approved a proposal to encourage research for Atmanirbhar Bharat in keeping with the spirit of National Education Policy-2020. The project named as subject cited above will focus on various areas which interalia include:-

- 1. Finding solutions to the contemporary problems being faced by various systems including Agriculture, Industry, Social System, Economy and Technology etc.
- 2. To create authentic databases for policy formulations and implementations
- 3. To explore areas of growth for creating more livelihood options for the youth of Haryana
- 4. Research in the emerging areas of science, technology and applications of science and technology

Forty seven topics have been identified through consultative meetings for the present. An amount varying from Rs. 75,000 to 1,00,000 depending upon the size/scope of each project would be available on the recommendations from Experts. To this sponsoring institution would also rope in 25% matching share through CSR.

CM's Research Fellowship For Science, Technology, Social Science, Humanities, & Problem Solving Research

Background: National Education Policy 2020 has duly emphasized upon research as a critical area for growth and sustenance of vibrant economy, uplifting society, and continuously inspiring a nation to achieve even greater heights. A robust ecosystem of research is more important than ever with the rapid changes occurring in the world today. In order to promote research, ecosystem in higher educational institutions in Haryana, the Council proposes to fund the research projects which would mainly focus on:

- a) Finding solutions to the contemporary problems being faced by various systems including Agriculture, Industry, Social System, Economy and Technology, etc.
- **b)** To create authentic databases for policy formulations and implementations.
- c) To explore areas of growth for creating more livelihood options for the youth of Haryana.
- **d)** Research in the emerging areas of science, technology and applications of science and technology.

I) INTRODUCTION

Haryana State Council of Higher Education, through Higher Educational Institutions (HEIs) strives to promote applied-cum-socially relevant research in emerging areas in Humanities, Social Sciences, Languages, Literature, Basic Sciences, Engineering & Technology, Agricultural Sciences etc. Themes and topics such as educational issues, health issues, social behavioral issues, environmental issues, biotechnological issues, managerial issues, global economy and its impact on the state, history of Indian science, Indian philosophy and many other areas will be identified. subject matter expert. There are subjects such as Defense and Strategic Studies which include national security matters, insurance and banking, economics and world trade, which are multidisciplinary in nature in the true sense, cutting across the disciplines of science, humanities and social sciences, and have a significant are areas. Rapidly changing global scenario. There is a need to study and research these and related topics in a more organized manner. The institutionalization of such activities is the need of the hour in the State of Haryana by the HEIs.

II) OBJECTIVES

The universities and colleges have to be developed as leading centers of research. Although the government has a network of science and technology laboratories for research and development, the major base of researchers in science and technology remains with universities and colleges. Therefore, there is a need to support university and college teachers to meet their needs for individual research in specific socially relevant areas. To promote excellence in research in higher education by supporting the research projects of university and college teachers in various disciplines in the State of Haryana.

III) ELIGIBILITY/TARGET GROUPS

Teachers working in government aided and self-financing state universities and colleges or retired are eligible under this scheme. A teacher, working or retired can avail only one project/ scheme of the State Council at any given time. The one, which is offered and accepted first irrespective of Principal Investigator/Co- Investigator, must be completed before the other offer is accepted.

IV) TYPES OF FINANCIAL ASSISTANCE INCLUDING RECURRINGAND NON-RECURRING

The quantum of financial assistance for a research project will be decided by the panel of experts on the merit of the proposal, hence, there is no fixed quantum of assistance. However, the Council will consider financial support for the items like Equipment, Books and Journals, Project Fellow, Hiring Services, Contingency, Chemicals and Consumables, Travel and fieldwork, etc. on the specific recommendations of the panel of experts. The TA/DA, HRA and other allowances to research team will be admissible as per State Government rules, applicable from time to time. The over all ceiling for each project may vary from Rs. 75,000 to 1 Lakh to which sponsoring authority may also contribute 25% by roping in resources through CSR/ other organisations.

V) PROCEDURES FOR APPLICATION INCLUDING SCRUTINY METHODS

All eligible permanent teachers may submit their proposals cum applications in the prescribed proforma available on the Council website. Before submitting to the Council the concerned institute should get the proposal assessed by their well-established research bodies with a certificate that the proposed research work is in conformity with the Council guidelines. The two copies of the same duly forwarded by the Registrar/Principal of the concerned University/College/Institution should be brought at the time of interaction with the panel of experts, however, one copy should be sent as advance copy to the Council Office.

VI) PROCEDURE FOR APPROVAL OF ASSISTANCE

The proposals received duly forwarded by the concerned Universities/Colleges will be assessed with the help of a subject expertcommittee constituted by the Council. The Principal Investigators whose proposals found complete in all respect will be invited for making presentations before the Committee. The TA/DA would be paid to the participants as per State Government rules. The final decision will be taken by the Council on the basis of recommendations made bythe Committee and the availability of funds under the scheme.

VII) PROCEDURE FOR RELEASE OF FINANCIAL ASSISTANCE

The first instalment of the grant shall comprise of 50% of the Non- Recurring including Over Head Charges, and 50% of the total Recurring grant approved by the Council for the total duration of the project. The grant will be released to the Registrar/Principal of the University/College who will closely supervise/monitor the expenditure in judicious manner. The amount released may be spent according to the approved heads/items within the approved allocation mentioned insanction letter. After one year from the date of implementation of the project the Council will organize mid-term evaluation interface meeting wherein Principal Investigator will present the progress of the project before the subjects' experts. On the basis of recommendations of the experts, progress report, expenditure statement and utilization certificate, the Council will release the 50% balance of the total recurring grantas the second instalment.

VIII) THE OUTCOME-BASED MONITORING PROCESS

After the completion of project tenure as per the Council offer letter, the parent institution of the Principal Investigator should arrange to make the final assessment/evaluation of the project minimum by two expert members not belonging to their institution duly nominated by Registrar/Principal. Then institution should forward the completion documents along with the expert committee report in the prescribed proforma notified by the Council. The publication of research papers inreputed journals would be appreciated by the Council as expected outcome in this regard, however, the final project report will be submitted by the Principal Investigator in Council's Office within three

IX) PROCEDURE FOR UTILIZATION FINANCIAL ASSISTANCE

The Principal Investigator, through the institution concerned, will submit the final utilization certificate (along with the project report) duly signed by the Principal Investigator, Registrar/Principal and the Chartered Accountant.

X) TEMPLATES OF FORMATS FOR RESEARCHERS

The Council will devise, from time to time, the templates of various proformas or formats for the ready reference of the Principal Investigator and research team.

XI) MISCELLANEOUS PROVISIONS

Principal Investigator on approval from the Council may publish the results of the study on the project acknowledging the contribution made by the staff appointed for the project and the support received from the Council. Project Fellow engaged in the project may enroll for Ph.D. The data generated and the results obtained out of the Project may be incorporated by the Project Fellow in his/her thesis with the concurrence of the Principal Investigator. If a Principal Investigator fails to complete the project, he/she has to refund the entire amount sanctioned with interest. No extension in tenure of the project is permissible in any circumstances. Project so awarded by the Council is not transferable in any case.
