Whereas Haryana Govt. is committed to implement NEP-2020 in letter and spirit.

Whereas NEP-2020 envisions holistic education including vocational education right from pre-school to higher education.

Whereas it has numerous parameters which are to be taken care for implementation by various stakeholders including the Departments.

Whereas the policy is to be implemented in a mission mode and fixed time frame.

Therefore as per approval of the State Govt., Haryana State Higher Education Council would henceforth be nodal agency to ponder over, monitor, handholding, mentor the progress regarding implementation of NEP-2020 as a whole encompassing departments/stakeholders such as School, Higher cum Technical Education, Women and Child Development Departments, Universities etc..

And, therefore, for the implementation of these decisions, the State Govt. has decided to

- Establish PMU in HSHEC. The process for engagement of Experts to be drawn under out-sourcing by inviting proposals from HARTRON empanelled agencies be initiated and funded by the Department of Higher Education and further modalities for deployment of manpower be worked out with mutual consultations between Department and Council.
- 2. Likewise another Cell by roping in suitable working manpower as also retirees be created for overseeing and managing the affairs of PMU and be also established in Haryana State Higher Education Council.
- 3. For incurring expenditure for the functioning of PMU and cell, a separate budget head with suitable provision of funds be made for that proposal be sent to Finance Department. Meanwhile the expenditure may be incurred from the budget head of IT of the Dept. of Higher Education.
