Greetings from Haryana State Higher Education Council!

Your kind attention is invited to the following guidelines issued by UGC/MoE Govt. of India:-

- 1. Guidelines for Curriculum and Credit Framework for Postgraduate Programme The UGC has developed the Curriculum and Credit Framework for Postgraduate Programme while considering the restructured degree programmes, entry and exit procedures, etc. The framework is a testament to student empowerment, giving them freedom, flexibility and choices. The framework, which has no discipline-specific entry requirements and shows the credit structure and curriculum contents for both one and two-year PG programs, flexibility to switch to alternative modes of learning (offline, ODL, Online learning and hybrid modes of learning) and also offers an exit option of the first year in two-year PG programmes.
- 2. Guidelines for Innovation Pedagogical Approaches and Evaluation Reforms-The NEP 2020, in its Para's, namely, Para 4.4, Para 9.3 (d), Para 11.6, Para 12.1, Para 12.2 and Para 12.6, envisions innovative pedagogical approaches and their role in higher education. The policy emphasises the holistic development of the learners, which requires using innovative pedagogical approaches such as experiential learning, cutting edge pedagogy, art integrated learning, flipped classroom etc. The policy gives teachers more autonomy in choosing aspects of pedagogy so that they may plan teaching-learning in the manner they find most effective for the students in their classrooms.

It is hoped that the Universities might have initiated action on the above guidelines by now. Hence a request to share an updated status for record.
