Subject: Regarding celebration of Jan Jatiya Gaurav Diwas, 2024 from 15th November to 26th November, 2024-reg.

आदरणीय महोदया/महोदय,


As you are aware, the Ministry of Tribal Affairs has declared 15th November, the birth anniversary of Bhagwan Birsa Munda, the legendary freedom fighter and tribal leader, as Janjatiya Gaurav Diwas. It has been decided to celebrate 4th Janjatiya Gaurav Diwas (JJGD) from 15th November and leading up to 26th November 2024 to coincide with the Constitution Day across the country. Further, the 150th birth anniversary of Bhagwan Birsa Munda will be commemorated next year and year-long celebrations held throughout the country from 15.11.2024 to 15.11.2025 as Janjatiya Gaurav Varsh (JJGV). To make this celebration meaningful, an illustrative list of activities received from Ministry of Tribal Affairs is enclosed as Annexure.

All the Higher Education Institutions (HEIs) are requested to leverage the pool of Ek Bharat Shrestha Bharat (EBSB) Coordinators/ Nodal Officers/ Faculty for coordinating and organising the events during the JJGD period from 15th to 26th November, 2024 and upload the documentation of events on MYBharat Portal (<https://mybharat.gov.in>). The Nodal Officer shall also be responsible for sharing the calendar of events for the period from 15th-26th November and for the entire commemorative year up to 15.11.2025.

Further, HEIs are requested to take necessary action and disseminate the information about the 'Janjatiya Gaurav Diwas' and 'Janjatiya Gaurav Varsh' among the students and faculty members to maximize student participation in the various competitions and ensure the success of this JJGD 2024 and JJGV. The HEIs are requested to upload the activities on the MYBharat portal after the creation of event of the same.

General Instructions:

- i. Need to organize JJGD in a meaningful manner, with active participation of all concerned stakeholders
- ii. Participation should be very wide, and messaging should be an important part of this celebration. The celebration should not be an end in itself but should lead to active participation in meaningful and creative activities related to improvement in education, health and livelihood aspects. Preservation and promotion of tribal culture would also be a significant part of the celebrations.
- iii. A calendar of activities for the period from 15.11.2024 to 26.11.2024 and from 26.11.2024 to 15.11.2025 may be got prepared. In the first instance, a calendar from 15.11.2024 to 26.11.2024 and upto 31.12.2024 may be prepared and sent to this Ministry by 2.11.2024. Thereafter, the entire year's calendar may be prepared and shared with this Ministry by 15.11.2024.
- iv. **Illustrative list of Activities for the JJGD and JYG Varsh:**
 - a. Floral tributes in the educational institutions and hostels of residential institutions to Bhagwan Birsa Munda and other tribal freedom fighters on 15.11.2024
 - b. Installing selfie points (as shared by the MoTA on its portal/website) for the students and faculty to take selfies
 - c. Organization of age-appropriate training/workshops on tribal art, dance, music, crafts, culture, contributions to Indian society, especially in the freedom struggle and protection of environment
 - d. Honouring of tribal achievers, including outstanding tribal scholars, who can serve as role models for the students
 - e. Outreach activities to the tribal communities by students – such as involving in Swatchata activities, plantation initiatives, each one teach one, enrolment in NSS/NCC/MyBharat
 - f. Cultural events such as dance, drama, music, painting and other arts and crafts associated with tribal communities
 - g. Quizzes on tribal freedom fighters, tribal culture and heritage, tribal crafts etc may be held
 - h. Competitions
 - i. Painting
 - ii. story writing

- iii. poetry
 - iv. dance,
 - v. music,
 - vi. drama,
 - vii. *nukkad nataks*,
 - viii. skits,
 - ix. short-write ups (250-500 words on the topic *know my tribe/ Tribal Freedom Fighters. Tribal Achievers, Tribal Languages etc.*) and
 - x. any other field as well as quizzes may be held on various aspects of tribal matters
 - xi. Learning of Tribal Languages and Tribals ways of life
 - xii. Capacity building of faculty may also be taken up. Training of Trainers & others may also be taken up.
- i. Where the institution is a hostel or a residential one, at least one item in at least one of the daily meals during this period may be a tribal recipe, so as to introduce the students to the culinary heritage.
- j. Encouragement to POSHAN vaticas in the institutions, as well as plantation activities, including the adoption of a tree by each student.



Respected Madam/Sir,

Greetings and felicitations from the Union Ministry of Social Justice and Empowerment.

As you are aware, on 26 November 1949, the Constituent Assembly adopted the Constitution of India, which came into effect on 26th January 1950, thereby making the beginning of a new era in the history of India. This day holds immense significance as it marks the establishment of the world's longest written Constitution and represents the triumph of democracy.

2. Union Ministry of Social Justice and Empowerment has been declared as the Nodal Department for the celebration of Samvidhan Diwas (Constitution Day). To mark the significance of completion of 75 years of adoption of Constitution, it has been decided to plan for a yearlong celebration in campaign mode. The commemoration shall begin on 26th November 2024 which marks the Constitution Day (Samvidhan Diwas). The yearlong celebration will be implemented under the campaign tagline "**Hamara Samvidhaan, Hamara Swabhimaan**".

3. Since its inception, the Constitution has been successfully guiding the path and development of India. Through the yearlong celebration, we aim to pay grateful tributes to "**we the people**"- the soul of India and the conscience of the Constitution and to the founding fathers of our Constitution. The commemoration shall aim to reiterate the principal values expressed in the Constitution of India and encourage the citizens to play their rightful role in strengthening Indian Democracy. Further, it shall aim to create awareness of the efforts made towards the making of our Constitution and its important provisions. The timeless messages and aspirations enshrined in our Constitution shall be brought to each household as part of this celebration.

4. The commemoration celebrations will be yearlong and the activities would be centred on the following four pillars:

- (a) Preamble of the Constitution
- (b) Know Your Constitution
- (c) Making of the Constitution
- (d) Celebrating the Glory of the Constitution.

5. The purpose of writing this D.O. letter is to draw your personal attention to the theme of **75 Years of India's Constitution - "Hamara Samvidhan, Hamara Swabhimaan"** and to request your esteemed educational institution to organize activities promoting Constitutional values among students. Students may be encouraged to take leadership roles ensuring their active participation in spreading the enduring message of our Constitution among the younger generation and their families in line with our earlier celebrations of "Azadi Ka Amrit Mahotsav", "Har Ghar Tiranga", and "Swabhav Swachhata - Sanskaar Swachhata". Furthermore, students in higher education may be encouraged and facilitated to write about their life journeys, aspirations and agendas for the future, with a focus on how the Constitution has been shaping their lives and living. These writings can be written in their mother tongues, State language or in English, providing a platform for personal reflection and expression.

6. I request you to take personal interest and use your experiential knowledge to nurture higher human aspirations among our young students. Hope your esteemed Institution shall help empower a generation of thoughtful and committed leaders who will take society forward during this yearlong celebration, aiming for a *Vikshit Bharat @ 2047*.

7. Finally, I request your esteemed institution to document all events, activities and celebrations in a contextually appropriate manner. The best initiatives- such as essays, papers, and articles- may be recognized and showcased through your Institution's publications.
