It is further, provided further that the State Government on the recommendations of Chairperson of the Council may add additional members/special invitees, as may be required.

One-fourth members of the Council including the Chairperson and the Member Secretary present in person shall form the quorum at every meeting of the Council.

Provided that if within fifteen minutes from the time fixed for the meeting quorum is not available, the meeting shall stand **adjourned**. The adjourned meeting may take place after two hours on that very day or as decided by the Chairperson as, no quorum shall be required for a meeting taking place after adjourned once and the members present may transact the business for which the meeting was called for.

The meetings of the Council shall be held as per requirement. However, it shall be mandatory to convene at least two meetings in a year at least once in six months.

The Member Secretary of the Council shall convene the meeting of the Council on the advice of the Chairperson.

No act or proceedings of the Council shall be invalid merely on the ground of the existence of any vacancy, absence of member or defect in the constitution of the Council.

Any member may forward a resignation letter to the Chairperson but shall remain as a member till he is informed in writing that his resignation has been accepted by the Chairperson.

The members shall be entitled to receive such travelling allowances, daily allowances, local expenses and participation fees, as may be specified by the Council.

If any emergent vacancy occurs due to death, resignation, retirement or any other reason, the State Government shall nominate or appoint a member.
